Eligibility: Original pop culture, science, and engineering themed artwork by invited artists. Commercially manufactured works will not be accepted. Each artist may enter up to four (4) pieces of artwork. Please submit photos of all artwork with application. All artwork must be ready to hang or display for gallery installation. For hanging pieces, work must be framed, ready for hanging, with wire that should not extend above the top of the frame. Work not properly framed and/or wired will not be exhibited. All other work (3D/Sculpture) must be ready to display in gallery setting. Artist may provide preapproved display items if needed. Please complete entry description for each entry, noting the medium of each piece. The Art Station-Big Shanty (TAS) will make the final determination of display arrangement and reserves the right to not display all pieces submitted.

Delivery: Artists will be responsible for hand-delivery of work to and pick-up from The Art Station. The artist is responsible for any insurance on his/her work during transit and exhibition. No artwork is to be shipped directly to The Art Station. **No group or school submissions please.**

Sales: The artist will receive 70% of the sale price (set by the artist). The Art Station will retain a 30% commission. The price submitted on Entry Form (attached) will be the price represented throughout the duration of the show. Changes are unacceptable. Sales tax will be added at the point of sale. In the event of a sale, artist must complete a W-9 and complete the Cobb County Vendor Enrollment process (unless already on file) prior to payment being made for sale(s).

Agreement: Submission of works to this exhibition constitutes agreement on the part of the artist to all terms and conditions of this entire prospectus, which includes, but is not limited to, the right of The Art Station and The Maker Station to use entries for publicity.

Liability: Neither The Art Station, Cobb County PARKS, nor The Maker Station will be held responsible for lost or damaged artworks. The artist is responsible for any insurance on his/her work during transit and exhibition. While utmost care is given to all entries, The Art Station and Cobb County PARKS do not assume any liability for damage or loss, before, during or after exhibition.
