The parties agree as follows:

1. The above-named artist agrees to have the Art Station-Big Shanty (hereafter referred to as TAS) exhibit their works as listed on the Inventory and Release Sheet enclosed herein and completed by the artist. **This inventory list should include: Artist name, title of work, medium, price or NFS.**
2. TAS shall have the artwork listed on the Inventory and Release Sheet for the following period including set-up and takedown. Please refer to the Important Dates page.
3. The above-named artist understands that the Gallery at TAS is open free to the public as follows: Tuesday-Friday 10:00 AM-5:00 PM. Call for night and weekend hours.
4. There will be an opportunity to meet the artists at the Opening Reception. Please refer to the Important Dates page.
5. All publicity including the name of the Art Station-Big Shanty and Mostly Mutts must be approved by the Art Station-Big Shanty Mostly Mutts prior to printing.
6. Mostly Mutts is a 501© (3) non-profit organization, licensed by the Dept. of Agriculture and staffed by volunteers. It is privately funded through donations and adoption fees and shall retain 30% of any sales made from the exhibition. Artists may choose to donate 100% of their sales to Mostly Mutts and must indicate so on the signature page.
7. All pieces must be original artwork of the above artist. Please do not submit work from previous *Off the Leash* shows. All work is subject to approval by TAS staff.
8. Unless otherwise specified to TAS staff in writing by the artist, photos of the works of art may be taken for TAS and Mostly Mutts publicity and archives and by the public.
9. For hanging pieces, all work must be framed, ready for hanging, with wire that should not extend above the top of the frame. Work not properly framed and/or wired will not be exhibited.
10. TAS has a security system, but insurance of works of art while in the possession of TAS rests with the artist.

I fully understand that the Art Station-Big Shanty, Cobb County P.A.R.K.S. Department, Cobb County Board of Commissioners nor anyone associated with the Art Station-Big Shanty will not be held responsible for the loss of artwork due to theft or damage. I further understand that insurance rests solely with the artist.

I understand and will comply with the terms set out in the Artist's Agreement.

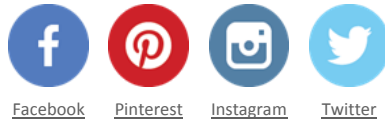
